

MASTER'S DEGREE IN INFORMATICS ENGINEERING (MUIINF) ACADEMIC CALENDAR 2026/2027 ACADEMIC YEAR

Approved by the School Board on 5th February 2026.

The academic year begins on **1st September 2026** and ends on **31st August 2027**.

PREREGISTRATION

- **Phase 2**
 - Submission of applications: from 15th to 26th June 2026.
 - Deadline for consideration of academic conditions: 14th July 2026.
 - Resolution of applications by the CATs: until 21st July 2026.
 - Publication of pre-registration results: 22nd July 2026, from 2 p.m. onwards.
- **Phase 3** (Provided that there are vacancies)
 - Submission of applications: 31st July to 7th August 2026 and 24th August to 4th September 2026.
 - Deadline for consideration of academic conditions: 7th September 2026.
 - Resolution of applications by the CATs: until 10th September 2026.
 - Publication of pre-registration results: 11st September 2026, from 2 p.m. onwards.

PERMANENCE

- **Submission of student applications**
 - General deadline: From 14th to 15th July 2026
- **Automatic disengagement:** Disengagement of students who do not apply to continue their studies within the established deadline.
 - 16th July 2026
- **Resolution and notification**
 - General deadline: Until 24th July 2026

RE-ENROLLMENT

In the case of students who have been dismissed from their studies due to non-compliance with the requirements of permanence and wish to apply for reinstatement.

- **Submission of student applications**
 - General deadline: 1st to 30th June de 2026
- **Resolution and notification**
 - General deadline: Until 10th July 2026

REGISTRATION

The instructions for completing registration are included in the online registration documents which can be found on the UPV home page (www.upv.es) The registration deadline is as follows:

- **New Students.**
 - Admitted in Phase 1 of pre-enrolment: 5th and 8th June 2026.
 - Admitted in Phase 2 of pre-enrolment: 23rd and 24th July 2026.
 - Admitted in Phase 3 of pre-registration: 14th and 15th September 2026.
- **Students in their second year or following years.**
 - Registration on 27th and 28th July 2026.
- **Students who have been authorized to re-enter the degree program.**
 - Registration on 29th July 2026.
- **Students who request a waiver of the continuance regulations and obtain enrolment authorization.**
 - Registration: As of 29th July 2026.

Registration cancellation

- Deadline: 31st October 2026.

In case of acceptance, the cancellation of the registration implies the total or partial cancellation of subjects of the course and implies the reimbursement to the student of the amount paid up to that date corresponding to public prices for teaching activities. After the general deadline, registration cancellation requests may be accepted, and the economic effects will be indicated by their resolution.

CLASS PLANNING FOR YEAR ONE

Semester A

Welcome Days, which must be attended by all new students, will be held on 4th September 2026.

The first semester starts on 7th September 2026 and ends on 29th January 2027.

Semester B

The second semester starts on 1st February 2027 and ends on 25th June 2027. In this semester there is a change in teaching staff:

- On Tuesday 16th March 2027 students will be taught lessons planned for Friday.

CLASS PLANNING FOR YEAR TWO

Semester A

The first semester starts on 7th September 2026 and ends on 29th January 2027.

PLANNING FOR PIECES OF ASSESSMENT

After the end of each semester, the following days are reserved for assessment events:

- Semester A: from 7th January to 29th January 2027.
- Semester B: from 7th June to 25th June 2027.

DEADLINE FOR PRESENTING RECORDS

The deadline for handing in records will be 19th February 2027 for semester A and 9th July 2026 for semester B.

In the case of the second year, semester A, the deadline will be 19th February 2027.

END OF MASTER'S DEGREE PROJECT

Registration and Cancellation

Registration will be carried out within the period established for this purpose in the academic calendar of each course, on the date assigned in the self-registration process. Registration may be cancelled before 31st May 2027, provided that the defence of the work has not been initiated.

Allocation of end of Master's Degree Project

End of Master's Degree Projects will be allocated at the beginning of the academic year. For the agreed external projects, allocation will be done throughout the academic year. In any case, please consider that there must be a 10-week gap between being allocated a project and requesting an appointment to defend the project.
