RULES OF THE OFFICIAL ANNOUNCEMENT FOR POLINIZA DOS 2016 (URBAN ART FESTIVAL)

1. PURPOSE

The Office of Cultural Activities of the Vice-Rectorate for Students Affairs and Campus Life is organizing, within the program of activities of POLINIZA DOS 2016 (Urban Art Festival), a meeting for wall painting; a painting done on an architectural support plastically and symbolically associated with its urban environment.

2. REQUIREMENTS FOR PARTICIPATION

The official announcement is open to all artists over 18 years old interested in taking part individually or collectively.

Those selected by the jury must present a project with the aim of creating a pictorial wall mural from 16^{th} to 20^{th} May 2016 inclusive, every day from 10 am to 6 pm on the walls authorised for this on the Campus de Vera of the UPV.

3. APPLICATION FOR THE REGISTRATION AND TIMELINE

The timeline for the registration and applications is from March 14th to April 8th inclusive. The registration form must be downloaded from the festival's official website www.upv.es/poliniza/ and completed. In addition, the contestants must present a digital portfolio or a link with the work that will be presented.

All of this must be presented to the General Registry of the Universitat Politècnica de València, located on the ground floor of the 3F building of the Campus de Vera (Camino de Vera, s/n. 46022, Valencia); the Registry of the Escuela Politécnica de Alcoy (Plaza de Ferrándiz y Carbonell s/n. 03801 Alcoy, Alicante); the Registry of the Escuela Politécnica Superior de Gandia (C/ Paranimf, 1. 46730 Grao de Gandia, Valencia); or in any of the ways described in article 38.4 of the Law 30/1992, on the Legal Regime of Public Administrations and the Common Administrative Procedure, drafted in accordance with the Law 4/1999 of January 13th.

4. PANEL OF JUDGES

The following representatives of the Universitat Politècnica de València will make up the panel of judges: the Vice-Rector for Students affairs and Campus Life, the Director of the Office of Cultural Activities, the Vice-Dean of Culture in the Faculty of Fine Arts, a professor of the School of Building Engineering, the commissioners of POLINIZA DOS and a representative of the students.

After assessing the information provided, the panel of judges will select the participants for the event. At the same time, they must present a sketch of the project within 15 calendar



days from the communication of the resolution and they will commit to creating it in accordance with the terms contained in these rules.

The panel of judges shall function as set out in the rules of the collegiate organisations of Law 30/1992 on the Legal Regime of Public Administrations and the Common Administrative Procedure, modified by Law 4/1999 of January 13th.

5. SELECTION CRITERIA

The judges' assessment will take into consideration the following criteria:

- 1. Career and/or academic and art education
- 2. Participation in exhibitions, events, festivals and other urban art shows
- 3. Grants and prizes
- 4. Continuous work creating wall art in public spaces

6.DECISSION

The panel of judges will evaluate and suggest the winners and submit the proposal to the Rector for resolution.

The winner of the contest will be announced through the link 'Cultura' on the website www.upv.es (www.upv.es/entidades/ACU/index-es.html) and the POLINIZA DOS website (www.upv.es/poliniza/).

7. PRIZE

The grant total is 4200 euros, which are charged to the consignment 009010000-422-47110. The gross prize will be 600 euros for every piece of wall art completed with a maximum of 7 individual or collective pieces. In addition, the organization covers the travel, board and lodging expenses of the selected artists. Furthermore, the materials needed for the project will be provided to the participants. Prizes are subject to the appropriate tax deductions.

8. CONDITIONS FOR IMPLEMENTING THE PROJECT

The artists will transfer the rights of their works to the UPV, who may make free use of them. For his part, the Vice-Rectorate of Students affairs and Campus Life is committed to disseminating the prize through the usual channels and will provide the infrastructure and materials needed for the implementation of the selected project. At the same time, the author or group of authors are committed to completing the project presented within the established timeline.

9. ACCEPTANCE OF THE RULES

The participation implies both total agreement with and acceptance of these rules.

10. COPYRIGHT

The authors of the proposals presented will transfer all rights of reproduction, transformation and public communication free of charge to the Universitat Politècnica de València, without time limitations and on a global basis. For the purpose of this concession, transformation means the simple inclusion of the work presented in the database of the vice-rectorate.

10. DATA PROTECTION

The personal data provided by the contestants to the Universitat Politècnica de València within this official announcement will have the protection established in organic law 15/1999 of December 13th on Personal Data Protection.

11. APPLICABLE APPEALS AGAINST THE RESOLUTION

Against this official announcement or the resolution of this announcement, which exhausts legal channels, an appeal can be lodged for reconsideration by the body passing the resolution within one month from the day following the notification, according to the terms established in articles 116 and 117 of Law 30/1992 of November 26th on the Legal Regime of Public Administrations and the Common Administrative Procedure, or by contentious administrative appeal to the competent body within two months from the publication of this resolution.
