- a) Transcript of records of higher education degrees (bachelor and, if applicable, master's), submitted during the application process to be admitted into the European Master's degree Plant Health, with an explicit reference to the average grade obtained.
- b) English language certificates (level B2 of <u>CEFR</u> or above).

# **GENERAL REQUIREMENTS**

The General Requirements are laid out in the document "Bases Generales" of the present call for application. Particularly important: to be a self-funded student in the European Master's degree PlantHealth (i.e. student receives no other Erasmus scholarship from the PlantHealth Consortium)

#### SPECIFIC REQUIREMENTS

#### a) Academic requirements

To complete successfully all the courses of the winter semester of the master's degree at UPV (September 2023-February 2024), as defined by the program:

Course content | PlantHealth - European Master's Degree in Sustainable Cropping Systems (upv.es)

Since the deadline for UPV instructors to announce the grades of the winter semester is 21 February 2024 (after the period established to announce the list of beneficiaries and spots allocated), this requirement will be verified after the provisional allocation of spots. Thereby, all spots allocated before 21 February 2024 will be conditional and subject to the fulfillment of this requirement.





#### b) Language requirements

English B2 of <u>CEFR</u> or higher.

Any document or certificate accepted during the process of admission to the Master's Degree PlantHealth will be considered valid. However, only certificates listed in Annex II of the present call for applicants will be considered as a merit for the ranking formula described below.

# **RANKING OF APPLICANTS / SELECTION PROCESS:**

#### Ranking formula for the allocation of spots:

The spots available in the host universities will be allocated on the basis of the ranking formula described below.

# 0,50 x Grade + 0,50 x Language

**Grade** = Average Grade of the undergraduate degree used to be admitted into the Master's degree Plant Health. The grades of international degrees will be translated into the Spanish grading system following <u>this conversion table</u>. In the case of countries not included on the list, the conversion charts to be applied will be those of the Spanish Ministry of Education.

**Language** = Points will be allocated for each official language certificate of level A2 of CEFR or higher, as established in the chart below:

It is possible to accumulate points for different languages up to a maximum of 10 points. In the case of providing several official certificates of the same language, only the certificate with the highest level will be considered.

For the purposes of ranking, only language accreditations that have been attached along with the electronic application within the official application period will be taken into account.
