FRAMEWORK AGREEMENT ON COOPERATION

CONCERNING THE EXCHANGE OF STUDENTS AIMING FOR DOUBLE-DEGREES FROM

Preamble

In furtherance of their mutual interests in the fields of education and research, The Universitat Politècnica de València (hereafter referred to as UPV-EPSG), represented by Professor José Pastor Gimeno, and Fachhochschule Stralsund, Stralsund University of Applied Sciences (hereafter referred to as FH-Stralsund), represented by Professor Thomas Rasmussen, hereby agree to the following:

Article 1 – Aim of the Agreement

The aim of this agreement is to specify the general terms under which exchange students from FH-Stralsund studying at UPV-EPSG and from UPV-EPSG studying at FH-Stralsund may be awarded, upon successful fulfilment of all requirements for graduation at each institution, the academic degrees and diplomas of comparable academic levels from both institutions.

Article 2 – Scope of the Agreement

Both institutions agree to the following general forms of cooperation and general requirements for all students participating under this agreement. Detailed conditions for the double degree shall be established by specific study plans.

Article 3 – Number of students

Each academic year, the international co-ordinators of both institutions will inform each other of projected student flows for double-degree students. These flows may be negotiated prior to the deadline for submitting applications.

Article 4 – Selection and admission of students

The exchange of students under this agreement will be conducted in accordance with the following principles:

- Students are selected and admitted to the double degree programme based on their academic results, motivation and language skills.
- UPV-EPSG students should have an English language level not lower than B2 and are expected to receive language courses in German language at FH-Stralsund
- FH-Stralsund students should have an English language level not lower than B2 and a Spanish language level not lower than B1. They are supposed to receive Spanish language courses at UPV-EPSG.
- The selection is carried out in collaboration between the two institutions. Admission of students is always at the discretion of the receiving institution.
- Students will be responsible for covering the travel costs to the host country and living costs during the stay, including accommodation, books, equipment, consumables, language tuition prior to the commencement of coursework (where necessary), student union fee (if applicable) and other expenses arising out of the exchange.
- The host institution will render assistance to the incoming students in finding appropriate accommodation.
- Students participating under the terms of this programme will be entitled to participate in any introductory programme that may customarily be arranged for foreign students.

Article 5 – Study Plan and Course of Study

An individual study plan for the total duration of the double degree programme must be established and approved by the academic representatives of both institutions before commencing coursework. The individual study plan has to be revised in collaboration and in written form with the approval of the two institutions.

The exact length of the period of study required by the host institution in order to receive its degree will be decided on a case-to-case basis after an evaluation of the subjects completed by the individual student at the home institution.

The general pattern for the double degree is as follows:

Students from FH-Stralsund:

- 1. Semesters 1 to 4 (Common Core) at FH-Stralsund
- 2. At least 5th and 6th semesters at UPV-EPSG attending successfully at least 60 ECTS credits at UPV-EPSG
- 3. 7th and 8th semester at FH-Stralsund
- 4. Internship(s) and bachelor's thesis may be done either at FH-Stralsund or at UPV-EPSG

After successfully completing the first four semesters (120 ECTS) at FH-Stralsund, FH-Stralsund students will go on exchange to UPV-EPSG and attend at least one year (60 ECTS) within the "Grado en Gestión Turística" at UPV-EPSG.

FH-Stralsund students will complete their curriculum at UPV-EPSG by studying at least 2 semesters in the bachelor's program "Grado en gestión turística" in the same way as regular UPV-EPSG students do. In particular, they have to meet all requirements of the examination regulations which are necessary to achieve the "Grado en Gestión Turística" at UPV-EPSG.

Students from UPV-EPSG:

- 1. 6 semesters of study (Common Core) at UPV-EPSG
- 2. At least 7th and 8th semesters at FH-Stralsund attending successfully at least 60 ECTS credits, following courses they have not yet attended
- **3.** 9th semester either at FH-Stralsund or at UPV-EPSG. UPV-EPSG students have to do their compulsory Internship and bachelor's thesis.

After successfully completing the first six semesters (180 ECTS) at UPV-EPSG, UPV-EPSG students will go on exchange to FH-Stralsund and attend at least one year (60 ECTS) within the "Bachelor in Leisure and Tourism Management" at FH-Stralsund. During an additional 9th semester UPV-EPSG students may choose, if they want to do their internship and / or bachelor's thesis at UPV-EPSG or at FH-Stralsund. In case they choose FH-Stralsund, it is responsibility of the student to find an internship.

UPV-EPSG students will complete their curriculum at FH-Stralsund by studying at least 2 semesters (60 ECTS) in the bachelor's program "Leisure and Tourism Management" in the same way as regular FH-Stralsund students do. In particular, they have to meet all requirements of the examination regulations which are necessary to achieve the "Bachelor in Leisure and Tourism Management" at FH-Stralsund.

The period of full-time course work at the host institution should not exceed three semesters, and the total duration of the nominal study period for the individual student should not be prolonged by more

than one year. According to the European standard, one semester of full-time studies is equivalent to 30 ECTS credits. The individual student should, at the end of the period of study at the host institution be issued with an academic transcript with the courses successfully attended at the host institution totalling a minimum of 60 ECTS credits.

Requirements for FH-Stralsund students:

In order to be issued with the Spanish "Grado en Gestión Turística", the double degree student must first be admitted to UPV-EPSG as a regular student. A condition for admission is that the student has an appropriate knowledge of Spanish language. The Spanish *Grado* degree will be awarded upon successful completion of at least 72 ECTS credits (60 ECTS courses + 12 ECTS bachelor's thesis) as defined in the study plan. This will result in the automatic awarding of the "Grado en Gestión Turística" at UPV, providing the student has met all necessary requirements.

Requirements for UPV-EPSG students:

In order to be issued with the German "Bachelor in Leisure and Tourism Management", students must first be admitted to FH-Stralsund as regular students. A condition for admission is that the student has an appropriate knowledge of English language. The German Bachelor degree will be awarded upon successful completion of at least 72 ECTS credits (60 ECTS courses + 12 ECTS bachelor's thesis) as defined according to the initial study plan. This will result in the automatic awarding of the "Bachelor in Leisure and Tourism Management" at FH-Stralsund, providing the student has met all necessary requirements.

Article 6 – Bachelor's Thesis

The final degree project may be undertaken either at FH-Stralsund or at UPV-EPSG, and will be carried out under the supervision of one faculty member from UPV-EPSG and one from FH-Stralsund. The supervisor from the institution where the project is carried out will be the 1st supervisor and responsible for the arrangements of topic and subject area of the project, the faculty member from the partner institution will be the 2nd supervisor.

Article 7 – Validation of results

The receiving institution shall communicate the sending institution the results of each student at the end of each academic year. The parties agree that exams/courses shall be graded and awarded credits according to the rules of the institution where the exam/course is taken.

Article 8 – Tuition fees, costs

No tuition fees are required at the receiving institution for students involved in the double degree. Both parties agree to take action to obtain financial support for student exchanges under European programmes or from other financial resources.

Due to legal reasons, at UPV students from FH-Stralsund will have to pay the compulsory administrative fees in the same way as the local students.

Article 9 – Terms for students

Article 9.1 - Conditions for application

The deadline for submitting applications in both directions is 31st May. Each institution will screen its applicants for the double degree programme. The receiving institution will have the right to make the final decision on admission of nominated students. Acceptance letters should be mailed to the students by 15th June.

Applications must include curriculum vitae, a transcript of the student's records, including courses and marks and the application form for the UPV-FH-Stralsund double degree, duly signed and stamped by the home institution.

Article 9.2 – Conditions during study period

Students participating under this agreement shall be subject to the rules and regulations of the host institution. They will have the rights and privileges enjoyed by other students enrolled at the host institution.

Article 9.3 - Delivery of the academic degrees

Each institution decides, on its own internal criteria, if the student has fulfilled all requirements to obtain its degree. Each institution grants the student credit transfer from the partner university according to the rules, laws and regulations in force.

Article 10 - Academic and administrative representatives

Each institution will nominate its own academic and administrative representatives, and such representatives will be responsible for ensuring that measures are taken in accordance with this Agreement. The representatives will organize advisory and other academic services to students participating under this Agreement.

Article 11 - Terms of agreement

This Agreement shall have retroactive effect by both parties since the academic year 11-12 and will be valid for five years. Each institution may cancel this agreement provided that written notice of the intent is given at least six months prior to termination. Commitments already in progress shall be fulfilled.

Article 12 - Amendments or changes

Amendments or changes to this agreement shall be made in written form and signed by the duly authorised representatives of the institutions.

Six original samples of this agreement have been signed.

Article 13 – In case of controversy

The parties agree to solve in a friendly manner any controversy rising from the interpretation of the present agreement.

In the event that the disagreement cannot be resolved, the issue(s) will be submitted for arbitration; each party will appoint a member of the arbitration panel and one member will be chosen by mutual consent.
