

RECOGNITION OF SPECIFIC ACTIVITIES OF THE AGRO-FOOD ECONOMICS DOCTORAL PROGRAM

The regulations governing doctoral studies at the UPV, in its article 2.1 establishes that "In addition to the research activity of the doctoral student, doctoral training will include the completion of specific and transversal training activities, [...]. Each of these will be valued in equivalent hours, such that for the presentation of the doctoral thesis it will be an essential requirement to have passed at least 600 hours."

Each doctoral program has selected a set of activities to achieve these 600 hours. The table below lists the activities, their mandatory or optional nature, and the hours to be recognized in the first three columns. These activities are included in the document verified by ANECA for the Doctoral Program in Agrifood Economics and approved by the Doctoral Program's Academic Committee.

It is mandatory for a student to:

- Complete a minimum of 60 hours of cross-curricular training courses or other activities recognized by the Doctoral School Publish an article in a scientific journal indexed in the JCR or SCOPUS databases.
- Have a total of 600 hours recognized (cross-cutting and specific)

Procedure for recognition of the number of hours of training activities by the Academic Committee of the Doctoral Program:

- 1. As established by the regulations for doctoral studies at the UPV, each year students must submit a personalized doctoral student activity report, which must be approved in advance by the tutor and the thesis supervisor.
- 2. The Academic Committee will evaluate the training activities carried out in that year to obtain recognition for a certain number of hours.
- 3. Prior to authorizing the doctoral thesis defense, the Academic Committee will verify that all the activities established by the program as mandatory and the total number of 600 hours in the set of activities have been completed.
