

## EXTRAORDINARY EVALUATION ACTS FOR DEGREES AND DOUBLE DEGREES ACADEMIC YEAR 2024/2025

The possibility of carrying out extraordinary evaluation acts outside the general established deadlines, is established in order to enable students who have a small number of subjects left to pass to complete their studies without having to wait a year for an ordinary assessment.

**FIRST:** To allow the presentation of applications to students who meet the following conditions:

- In general, for the subject requested, there must be a grade in at least one previous call, not being considered for these purposes the grade of Not Presented.
- **For DEGREES:** To be enrolled in all the credits necessary to complete the degree (with the exception of the final degree project) and only need to complete a maximum of 20 ECTS credits to complete their studies, excluding the TFG and, if applicable, external works.
- **For DOUBLE DEGREES:** To be enrolled in all the credits necessary to complete the double degree itinerary (except for the two final degree projects), and only a maximum of 30 ECTS credits, excluding the two TFG's, to complete the double degree itinerary.

**SECOND.** Students may request indistinctly to attend the evaluation of subjects of the first semester, second semester or annual.

**THIRD.** Students who take part in this extraordinary assessment call in one or more subjects will maintain their right to be assessed in these subjects in accordance with the ordinary procedure and to attend the assessment sessions scheduled for each subject. Each student may only request one extraordinary assessment event for each subject in an academic year.

**FOURTH. CANCELLATION DEADLINE: 7 DAYS BEFORE THE EXAMINATION DATE.** It must be submitted by Poli[Consulta] to the Secretary's Office of the Centre. The student who does not attend the requested exam and has not submitted within the deadline, will be evaluated as NO SUBMITTED.
